Certified Comfort Systems, Inc. dba Hyde's Air Conditioning will conduct "**Celebration of Giving**" substantially as described in these rules and by participating, each participant agrees as follows:

1. **Description of "Celebration of Giving":** The purpose of "**Celebration of Giving**" is to find needy, deserving homeowners who reside in the Coachella Valley within Hyde's service area and their current heating and cooling system is old and needs help.
2. **Dates of "Celebration of Giving":** "**Celebration of Giving**" nominations will kick off on April 8, 2019, and will end at midnight on May 31, 2019. One winner will be announced and notified by June 14, 2019.
3. **How to Submit a Deserving Recipient:**
 - a. Applications can be submitted in one of 2 ways:
 - i. By visiting our website at www.hydesac.com/celebration-of-giving/ (fill out online and submit).
 - ii. By completing the nomination form (which can be picked up at Hyde's Air Conditioning) and submitting by mail to our address above or dropped off at our office located at the same address.
4. **How the Winner is Chosen and Announced:**
 - a. An five member committee will select the winner from the entries received between April 8, 2019 and May 31, 2019 and the winner (recipient) will be announced and notified by June 14, 2019.
 - b. If the winner (recipient) cannot be contacted within 48 hours of the announcement or it is determined by Hyde's Air Conditioning that the selection does not qualify, committee reserves the right to determine an alternate recipient.
5. **Gift:**
 - a. One new heating and air conditioning system, American Standard 16-SEER, (does not include duct work) will be awarded to the eligible recipient:
 - i. One new heating and air system will be installed by Hyde's Air Conditioning at the winner (recipient's) home.
 - ii. Installation to be performed during normal business hours and is based on scheduling availability.
6. **Eligibility and Limitations:**

- a. Participants must be U.S. residents, and reside in the Coachella Valley within Hyde's service area, be at least 18-years old, be the owner of the home on the application, must be living in the home, and must prove that they are deserving of a new heating and/or cooling system.
 - b. Each recipient must submit proof of eligibility and home ownership.
 - c. Employees of Hyde's Air Conditioning and members of the immediate family of any such persons are not eligible to participate and win. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriages(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.
- 7. Publicity/Use of Personal Information:** By participating, all participants and recipient(s) grant Hyde's Air Conditioning exclusive permission to use their names, characters, photographs, voices, and likenesses in connection with promotion and waive any claims to royalty, right, or remuneration for such use. By participating in "**Celebration of Giving**", participants agree that Hyde's Air Conditioning may disclose personal information obtained from participants in "**Celebration of Giving**" to third parties and use such information for marketing and other purposes.
- 8. Release:** By participating, each participant and recipient waives any and all claims of liability against Hyde's Air Conditioning, its employees and agents for any personal injury or loss which may occur from the conduct of, or participation in, "**Celebration of Giving**," or from the use of any awarded system. In order to receive a system, participants must sign an official waiver form provided by Hyde's Air Conditioning.
- 9. Decisions:** By submitting an application in "**Celebration of Giving**", participants agree to be bound by the decisions of Hyde's Air Conditioning personnel. Hyde's Air Conditioning reserves the right to disqualify any participant and may refuse to award a system to a person who is ineligible or who Hyde's Air Conditioning believes has violated any rule, gained unfair advantage in participating in "**Celebration of Giving**", or obtained winner status using fraudulent means. Hyde's Air Conditioning will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules; and Hyde's Air Conditioning decisions concerning such disputes shall be final.
